



Location

The property is located on Dryden Street, Leicester, at its junction with Old Milton Street. Positioned within an inner city location adjacent to the Inner Ring Road (A594), access throughout the County is good, whilst also being c. 4.5 miles from J21 (M1/M69 intersection).

Description

The property is constructed around a frame structure to two storey height with solid floors throughout. Briefly, the property comprises entrance reception with two mainly open plan floor plates, with the addition of a mezzanine floor. Suspended ceilings with inset LED lighting are installed throughout.

Loading is facilitated off Old Milton Street by way of two roller shutters, including 500kg goods lift allowing for the movement of goods to the first floor. An area within the building has previously been used to park 3 vehicels.
